On January 24, we hosted the sold-out, inaugural Community Health Worker Summit at the Chicago Cultural Center. Ohio Council for Home Care & Hospice (OCHCH) Partners with The HAP Foundation

Ohio Council for Home Care & Hospice (OCHCH) has engaged in a partnership with The HAP Foundation to increase value for members through educational courses, advocacy support, and grant opportunities. The HAP Foundation team of expert leaders in hospice, palliative, and serious illness care will provide OCHCH leadership with counsel and advice as they plan to expand their offerings for member providers and patients across Ohio.

CHW Apprenticeship Opportunity with HAP

The HAP Foundation has registered a one-year Community Health Worker (CHW) Apprenticeship with the United States Department of Labor (DOL) to support the growth of CHWs in the workforce. We announced this exciting opportunity of the CHWs and allies gathered at the HAP Foundation CHW Summit. This apprenticeship provides newly hired CHWs with learning modules and on-the-job training to develop the skills necessary to become a successful CHW. HAP's program offers a unique focus on supporting people living with serious illness, their care needs and options. Apprenticeship programs offer a practical path to a new career by integrating employment, education, and practical experience.

The CHW apprenticeship requires at least 144 hours of technical instruction and 2,000 hours of on-the-job training. Previous experience and education may be applied to each apprentice's individual plan. Participants must be at least eighteen, have a high school diploma or GED, and be authorized to work in the United States. Eligible participants may receive additional support for expenses related to their work while completing the apprenticeship. Employers may be eligible for certain tax credits or grant funding for worker training. To learn more about the program, click here.

AmeriCorps Senior Workforce Program Launch in Peoria, IL

On January 31st, HAP announced the launch of the AmeriCorps Seniors Workforce program in Peoria, Illinois. Through a federal grant, the senior workforce program will train 10 to 15 Peoria County individuals aged 55+ as Community Health Workers (CHWs). These CHWs will serve as links between health care and social service organizations to remove barriers and improve health outcomes for their fellow community members.

Participants will receive at least 40 hours of training in core competencies to become CHWs. Job training will be provided through partnering host health care or community organizations. Participants must commit to ten hours per week, with a monthly stipend of \$200. After completing the program, each participant is eligible to receive an additional stipend of up to \$1,000 through a grant from the Illinois Public Health Association. The full fair-market value of a gift of long-term property is deductible up to 30% of your adjusted gross income. You may carry forward any amount over the 30% ceiling for up to five additional years.

We will also learn about peace circles, what they are, and how they can be used in the community setting.
